Sealed tenders are invited on proformas attached herewith (Annexures A to C) for **SUPPLY OF 01 (ONE) MARUTI INVICTO HYBRID ALPHA+ IN WHITE COLOUR (PETROL), BY ORIGINAL EQUIPMENT MANUFACTURER (OEM)/ AUTHORIZED DEALERS OF MARUTI BASED IN DELHI AND NCR REGION** for use of the Chairperson of the Appellate Authority and the vehicle is to be registered in Delhi.

A. Procedure for offline Submission of Tender Document

The Tender for the above items are invited offline. The following procedure will be adopted for the offline opening of the price bids.

Submission of the Bids:

The bids will be submitted at our office with the following documents:

Technical Bid

1. Covering letter accepting terms and conditions of tender of the participating firm on letterhead.
2. Original Equipment Manufacturer (OEM) certificate or authorized dealership/distributorship certificate as applicable.
3. Detailed technical specifications highlighting the features of the vehicle.
4. Firms' Business Registration documents.
5. GST Registration No. of the firm.

6. Tender fee and Earnest Money Deposit (EMD) by Demand Draft, of any nationalized/ scheduled bank, in favour of the “**APPELLATE AUTHORITY**” payable at New Delhi.

Mode of sending the tender:

Two covers bid tender. Two separate envelopes consisting of technical bid (eligibility criteria) in one envelope and financial/commercial bid in another envelope. Both envelopes to be kept in main single envelope along with Demand Draft for the Tender Fee (₹ 1,000/-) and EMD (₹ 50,000/-) shall be submitted in sealed cover by registered speed post/Courier/by hand only.

Refund of EMD:

For Unsuccessful Bidders, EMD will be refunded/ returned on issuance of Purchase Order to the Successful Bidder, upon receipt of a written request, deducting necessary bank charges, if any, and without any interest.

For the Successful Bidder, EMD will be refunded/ returned after satisfactory completion of work as mentioned in the Purchase Order upon receipt of a written request by the Successful Bidder after deducting necessary bank charges, if any, and without any interest.

Description essential to be made on sealed cover:

The main single envelope must be superscribed as “Tender for supply of 01 (one) no. of Maruti Invicto Hybrid Alpha+ in White Colour (Petrol)”. Two separate covers superscribed as (1) Technical bid cover and (2) Commercial bid to be kept in main single envelope along with tender fee and EMD.

Inspection of Old Car Honda City – Model 2011 (Silver Colour):

The prospective bidders may visit for inspection of Old Honda City Car - Model 2011 (Silver Colour) parked at the Office of the Appellate Authority (i.e. ICAI Bhawan, A-29, Sector-62, NOIDA – 201 309) with the prior intimation/ permission during working hours, enabling themselves to quote the offer price for the exchanged value of the old car.

Date of opening tender:

- (1) **Part-1, Technical bid:** - This bid will be opened on **05th October, 2024 at 1:00 PM** at Appellate Authority, 2nd Floor, Research Block, ICAI Bhawan, A-29, Sector-62, NOIDA – 201 309 by the Committee of the Appellate

Authority/ICAI.

- (2) **Part-2, Financial/commercial bid:** - This bid will be open after the examination of pre-qualification and shall be opened for only those bidders who will succeed in technical Bid. The date and time of opening will be intimated accordingly through email.

General Terms and Conditions:

1. Only the manufacturer and their authorized distributors or dealers or channel partners having their dealership in Delhi/NCR need to submit their tender. The authorized distributors or dealers or channel partners should furnish a certificate from the manufacturer for their dealership.
2. No person or firm shall be allowed to submit more than one Bid.
3. It is mandatory to provide all the relevant documents as per the Tender document.
4. The Appellate Authority has been constituted by the Central Government vide its notification in the official Gazette dated March 20, 2009, in terms of Section 22A (1) of the Chartered Accountants Act, 1949, Section 22A of the Cost and Works Accountants Act, 1959 and Section 22A of the Company Secretaries Act, 1980. Hence vehicle is applicable to Government passing (G- Passing). The procedure of G-passing shall be followed by the bidder.
5. The Tender Bid should be accompanied with the detailed printed technical literature with specifications, make and model number of each item. Specifications given in the offer must be similar to the information available on the website and/or printed technical literature, otherwise, the offers shall be rejected.
6. The Tender Bid must provide a guarantee/warranty of satisfactory functioning of the vehicle for a period of at least two years from the date of purchase, alongwith the price of extended warranty for a period of further 05 years.
7. **Payment Terms:** The standard terms and conditions with regard to the payment would be treated as full and final at the time of delivery of the car.
8. Please quote the maximum discounted price, as no further negotiations will be made.
9. The Appellate Authority reserves the right to accept or reject any or all offers in full or in part without assigning any reason (s) therefore.
10. The process of purchase can be cancelled at any time without assigning any reason thereof.

B. Terms and Conditions of Tender

1. The Bidders are required to quote their lowest rates including Insurance Charges, Road Tax, Extended Warranty Charges and Maintenance Charges etc. for the above-mentioned **ONE MARUTI INVICTO HYBRID ALPHA+ WHITE COLOUR (PETROL)**.
2. The rates should be valid for a minimum period of 90 days from the date of opening of tenders. The bidder shall not be entitled during the said period of 90 days to revoke or cancel its bid or to vary the bid or any terms thereof.
3. Hypothetical or conditional Bidders will not be entertained. Tender once submitted shall not be allowed to be withdrawn or altered otherwise, and if so, the appropriate action will be taken against that Bidder, as may be deemed fit by the Registry. The Bidder shall be bound by the terms and conditions of the tender.
4. The Registry will deal with the bidder directly and any middlemen/agents/ commission agents etc. will not be entertained by the Registry. The Tender Form is non-transferable and agency shall not be permitted to transfer its rights and obligations to any other person/organization or otherwise.
5. Over-writing/over-typing or erasing of the figures which render it doubtful or ambiguous are not allowed and shall render the bid invalid.
6. The bidder shall give an undertaking (**as per ANNEXURE-A**) that the Firm/Partner/Director/Proprietor has not been blacklisted and its business dealings with Central/State Government/Public Sector Units/autonomous bodies have not been banned/terminated on the account of poor Performance.
7. The Registry, in its discretion, reserves the right to make any change, any time, in the terms and conditions of the Tender and accept or reject any or all the Bids, wholly or completely, without assigning any reason thereof at any stage of tendering process.
8. The bidder shall quote rates both in figures and words with blue/black ball pen. In case of any discrepancy, the figures mentioned in words will be considered.
9. The bidder should specifically mention whether rates are inclusive of GST or CESS (as applicable) and if it is not mentioned, it will be presumed that rates are inclusive of GST or CESS.
10. All the pages of quotations including the documents submitted therein must be duly signed and stamped failing which the Bid shall be liable for rejection.
11. The Registry is not bound to accept the rates submitted by the lowest bidder or any other bidder nor does it undertake to assign any reasons for its decision in this matter.
12. Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the

stipulations made herein or backs out after quoting the rates or violates any terms and conditions of tender, the EMD shall be forfeited and Bid shall be rejected.

13. The supply of **ONE MARUTI INVICTO HYBRID ALPHA+ WHITE COLOUR (PETROL)** will be inspected by an Inspection Committee of Senior Officers of the Registry and in case the supply is not found in conformity with the approved specifications, the same is to be replaced exactly commensurate with approved specification at the cost of the bidder. The decision of the Committee in this regard shall be final.
14. The payment will be made only after the delivery of car, if the same is acceptable as per approved specification.
15. In case less than two tenders are received, due to inadequate competition, the same may not be opened and more tenders may be called and will be opened later on at the place, date and time to be notified in due course.

C. Terms and Conditions for successful Bidder

1. The successful bidder shall be responsible for getting the HSRP (Delhi Number Plate), accessories, etc. affixed on the vehicles, after the delivery of the vehicle and at the premises of the Appellate Authority at its own cost.
2. The successful bidder will have to abide by the terms and conditions as may be fixed from time to time by the Registry.
3. The Vendor shall be responsible for all the documentation process with regard to the old Vehicle and will submit details of the transferee with the Registry within 15 days from the purchase of New Vehicle.
4. The tender should accompany an undertaking of Authenticity as per the Proforma placed at **ANNEXURE-B**.

D. Penalties

1. The delivery of the vehicles shall be required to be made within 30 days on receipt of the Purchase Order and in case supply is not received within the stipulated time and the Registry is forced to make a purchase/ hire to meet the urgent demand, the loss, if any, would be recovered from the bidder.
2. Irrespective of the fact as to whether or not the Registry may impose penalty of 1% per month subject to a maximum of 10% of the total cost, for delayed delivery, if the delay is caused due to willful laches or negligence of the bidder and it resulting into financial loss or inconvenience to the Registry.
